In the event legal action becomes necessary, the undersigned agrees that exclusive jurisdiction and preferred venue shall remain in Indianapolis, Marion County, Indiana, and all rights to change of venue or trial by jury are hereby waived. I/we authorize Reese to investigate my/our personal credit standing, financial circumstances and responsibility and authorize and instruct all persons having such information to release the information to Reese, its agents, or attorneys. This guaranty is a continuing guaranty of payment and shall inure to the benefit of Reese from the date hereof and shall remain in full force and effect until written notice of termination thereof has been received by Reese by certified mail. Termination of the guaranty shall not affect any of the guarantor's obligations hereunder with respect to indebtedness incurred prior to the termination.

All purchases are subject to a 2% cash discount if paid by the 10th of the month following the month of purchase, unless the amount specified is NET, in which case the full amount is due by the end of that month. You agree to pay a past due fee of 1% per month on all amounts which have not been paid by the end of the following month of purchase. Past due fees will be added to your account and used to compute past due fees for succeeding months.

You agree to be liable for all costs of collection and attorney's fees in the event of nonpayment in accordance with these terms, all without relief from valuation and appraisal laws. In the event that legal action becomes necessary, you agree that exclusive jurisdiction and preferred venue shall remain in Indianapolis, Marion County, Indiana, and you waive any right to change of venue or trial by jury. This agreement will be governed as to validity, interpretation, construction, effect, and all other respects by the laws of the State of Indiana.

You further agree that any line of credit desired or approved is not a limitation of liability, and you expressly agree that you will be responsible for charges in excess of a line of credit either desired or approved. The sale of goods by Reese Central Wholesale, Inc. ("Reese") shall be governed by the terms contained herein as well as all terms on the counter ticket and invoice that relate to a particular transaction, which terms are incorporated herein by reference. In the event an order receipt is not signed, the transaction itself will act as acceptance of the terms thereon and herein.

You agree to notify Reese in writing of any internal structural or ownership changes in the business status, and you agree to remain liable for all purchases and charges on your account until Reese confirms in writing that your account is paid in full and closed. Any material returned for credit must be returned within 60 days of purchase, must be a currently stocked item, and be in resalable condition, all in Reese's sole discretion.
